### Call out for Lands Committee Members

The Lands & Natural Resource Department is looking for at least five (5) and no more than eleven (11) community members to join the Lands Committee, a term on the committee lasts 2 years, except for the very first term in which half of the committee will serve for 3 years. The Lands office will assist with the work of the Lands Committee, and must consider advice provided by the Lands Committee in carrying out the Lands office responsibilities.



### Be apart of change

- Advising council and its staff on matters respecting LFN.
- Recommending Land Laws, Council Resolutions, policies and practices respecting LFN Land to Council;
- Consult with Membership and interest and Licence holders on LFN Land issues, and to make recommendations on the resolution of those issues to Council;
- Oversee community meetings of Membership, Membership Approvals and Votes; and
- Perform such other duties as may be delegated or assigned by Council Resolution or Land Law under the Land Code.



## TEMEEUH NA TA HHEEYMOT 'HOW WE DO THINGS ON THE LAND'

In addition to the responsibilities of the Lands Committee under the Land Code, the Lands Committee may advise Council and the Lands office on the following:

- Land matters, including the granting of Interests and Licences;
- Land use plans;
- Lands related policies and Land Laws; and
- Recommendations from Membership and others regarding lands and environmental concerns and priorities.

The Lands Committee will recommend to Council any Land Laws and policies for determining administrative fees, rent, royalties, or other amounts for:

- Interests and Licences;
- services in relation to Land, including fees for applications, registration, and transfers; and
- the taking of Natural Resources.
